Detailed Course Evaluation

- 1. More processing. For technical topics (EAD/XML), a brief intro to the background/theory/concept would have helped in my understanding and being able to follow the presentation. I learn from doing, not so much from hearing, so some more exercises in each topic area would be helpful.

- 3. Start at 8:00 a.m. instead of 8:30, and use the time gained for passage time if breaks continue to be offered out of the building. Those who rely on elevators and ramps take longer to move from one site to another, especially with the elevator situation at Beineke.
- 4. I felt that there was too much time devoted to seeing other people's workspaces; it was interesting, but took a lot of class time. I wish we could have had instructor-lead discussions, but not instructor-dominated discussions. {Private comment—RBS staff}
