IN RESPONSE TO THE COVID-19 PANDEMIC, IN FISCAL YEAR 2021, RBS OFFERED FOR THE FIRST TIME A FULL ROSTER OF ONLINE COURSES AS IN-PERSON INSTRUCTION REMAINED INFEASIBLE. IN FISCAL YEAR 2021, 807 STUDENTS WERE ADMITTED TO TAKE 36 COURSES OFFERED VIRTUALLY, ENGAGING IN COURSE DISCUSSIONS, LECTURES, AND RECEPTIONS ACROSS A DIGITAL PLATFORM.
